#### WE AMPLIFY

We listen to LGBTIQ activists on the front lines. From Ukrainian activists helping their communities during the war to Caribbean activists fighting to overturn colonial-era laws banning same-sex intimacy, Outright amplifies their voices.

We support a global movement that drives change across governments, institutions, businesses, and individuals. Outright holds consultative status at the United Nations where we serve as the secretariat of the UN LGBTI Core Group

### **KEY TALKING POINTS**

LGBTIQ communities worldwide are under attack. Here are some facts to share with your community.

64 jurisdictions
worldwide still **criminalize homosexuality**, in some
cases punishable
by death.

LGBTIQ people, especially transgender women, face disproportionately high rates of violence.

Crackdowns are rising on LGBTIQ activism in China, Russia, and many other places –and authoritarian leaders often scapegoat and target LGBTIQ people.

Harmful, abusive conversion practices are prevalent globally and can cause lasting trauma. An increasing number of laws and policies seek to further criminalize, marginalize, or even erase LGBTIQ communities, often promoted by oncesupportive governments.

Well-funded anti-LGBTIQ groups are coordinating efforts and attacks across borders.

The U.S. government's recent freeze on foreign assistance, dismantling of USAID, and specific and repeated targeting of LGBTIQ people have created a global crisis.

Several of the largest and longtime government and institutional funders of the LGBTIQ movement around the world are curtailing support.

We cannot remain passive while authoritarianism rises, marginalized communities face increasing attacks, and conservative, extremist donors invest millions to roll back fundamental human rights across borders.
